The Alabama Community College System Board of Trustees (also referred to herein as the Board) held a meeting at 10:02 a.m. on Wednesday, August 12, 2015, in the Board Room of the Alabama Community College System building in Montgomery, Alabama. The meeting was called in accordance with Act No. 2015-125.

JOHN C. CALHOUN COMMUNITY COLLEGE PURCHASE OF INSTRUCTIONAL EQUIPMENT

The Board authorized Calhoun Community College to purchase instructional equipment for the Industrial Maintenance Program. This purchase must be completed no later than February 28, 2016, or this authorization will expire. Fiscal consideration: \$130,000 (\$116,666 - Current Restricted Fund [Workforce Development Funds]; and \$13,334 - Current Restricted Fund [Perkins Funds])

FAULKNER STATE COMMUNITY COLLEGE ADDITION OF INSTRUCTIONAL SITE

ALABAMA COMMUNITY COLLEGE SYSTEM ALLOCATION OF THE 2015-2016 TWO-YEAR COLLEGE SYSTEM AND PRISON EDUCATION OPERATIONS AND MAINTENANCE APPROPRIATION

The Board approved the allocation of the 2015-2016 Education Trust Fund (ETF) appropriation for operations and maintenance of the two-year colleges and the prison education appropriation as recommended by the Chancellor. It is further recommended "That other details of the said Series 2015 Bond will be set forth in the attached resolution."

FISCAL CONSIDERATION

<u>\$645,000</u> – Approximate savings on the refunding (net present value)

RATIONALE

At its September 23, 2004 and December 14, 2006 meetings, the State Board of Education authorized the issuance of \$7,500,000 and \$8,000,000, respectively, in revenue bonds for the benefit of Bevill State Community College. Current interest rates provide a favorable climate for refunding the outstanding Series 2005 and Series 2007 Bonds; resulting in an estimated net present value savings to the college of approximately \$645,000.

RATIONALE

On August 12, 2015, the Board of Trustees approved Brookley Field in Mobile as an instructional site for Faulkner State Community College. Approval of the site was the first step in the process for the South Alabama Aviation Sites re-alignment for Faulkner State.

The next step in this process is the approval of an Associate in Applied Science Degree and Certificate Award in Airframe Technology. This is an existing program at Brookley Field and is currently offered by Enterprise

State Community College. Approval of this program for Faulkner State Community College will assure continuity for students currently enrolled in Airframe Technology.

The College projects that a total of \$5,064,896 in estimated new funds will be required to support the proposed program, and a total of \$5,064,896 will be available through internal allocations, tuition, and extramural funds. The Alabama Commission on Higher Education approved this program on September 11, 2015. More detailed information regarding this program follows this recommendation.

Faulkner State Community College Associate in Applied Science and Certificate in Airframe Technology

Program Description:

A program that prepares individuals to apply technical knowledge and skills to repair, service, and maintain all aircraft components other than engines, propellers, avionics and instruments. This program is designed to prepare students with the knowledge and skills needed to take Federal Aviation Administration (FAA) written, oral, and practical examinations required for certification as an aviation maintenance technician with an airframe endorsement.

Program Objectives:

Along with the Airframe Technology degree the student will also receive a variety of employability skills and work ethics that will allow him/her to be competitive in other elements of the aviation industry.

FAA certification is normally required to begin a career as an aviation maintenance technician. These technicians are in high demand by regional and national commercial airlines, in general aviation, and in support of the military and other governmental agencies that use aircraft.

To assess the program, a program review will be undertaken. The program review will consist of Level I and Level II reviews and may include Level III reviews. The Level I review of all programs is conducted by the Alabama Community College System. The Level II review is a complete review of the program by the College. Level I reviews processed by the Alabama Community College System may identify a program for Level II review at an earlier date than indicated by its assigned sequence. A Level III review is a system-wide review of a specific instructional program or programs initiated by the Chancellor and predicated upon the findings of instructional program reviews at Levels I and II. An advisory committee with representation from organizations being served by the program graduates will be utilized to periodically review the program's curriculum and advise the program on the establishment, review, and revision of the program objectives. The advisory committee will provide advisement on current and future aspects of the technical field for which the graduates are being prepared.

Program Need:

Pursuant to Alabama Act No. 2015-125, the Alabama Aviation College was established as an independent institution within the Alabama Community College System for providing aviation education and training statewide. Enterprise State Community College currently operates and administers the aviation programs located at Brookley Field in Mobile and at the Fairhope Airport (collectively referred to as the South Alabama Aviation Sites).

A review of the Alabama Aviation College's programmatic, financial, and instructional needs and partnership opportunities has determined that the South Alabama Aviation Sites program administration will be enhanced and better fulfill the mandates and directives of the Act if they are re-aligned and managed under the direction of Faulkner State Community College. In order to implement, promote, and effect such a re-alignment, proper approval will be sought and gained from the appropriate regulatory and accrediting agencies, including the Alabama Commission on Higher Education (ACHE), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Federal Aviation Administration (FAA), and the U.S. Department of Education. In the spirit of cooperation, the presidents of Enterprise State Community College and Faulkner State Community College are in agreement and signed the attached Memorandum of Understanding.

The Airframe Technology program is an existing program at Brookley Field-Mobile.

Projected Job Openings:

Established in 1976, the Mobile campus is located just off Interstate 10 at the Brookley Aeroplex on the western shore of Mobile Bay. It is close to the United States Coast Guard Aviation Training Center, within 40 miles of the Pensacola Naval Air Station, the primary training base for Navy and Marine aviation, and is near Eglin Air Force Base, Tyndall Air Force Base, and Keesler Air Force Base. The aviation programs offered across the AAC regions enhance our nation's ability to provide national security and pursue international initiatives.

There are numerous aerospace employment opportunities within a 60 mile radius of the Mobile campus. Companies include, United Technologies, Segers Aero Corporation, Airbus Military, Continental Motors, ST Aerospace, Star Aviation, PHI Helicopter Inc., Southern Avionics, and the new Airbus Final Assembly Line.

Employment of aircraft mechanics and technicians is projected to show little or no change from 2012 to 2022. Job prospects are best for mechanics holding an Airframe credential. In May 2012, the median annual wage for aircraft mechanics and service technicians was \$55,210.

Aircraft mechanics and avionics technicians held about 138,900 jobs in 2012. Approximately 88 percent were aircraft mechanics. The majority worked for private companies and about 14 percent worked for the federal government.

Brookley Field, an expanding aerospace industry hub, captured the global business spotlight recently when Airbus selected Mobile for its only assembly site in the western hemisphere. Construction has been completed on this \$600 million project and the first deliveries are expected in 2016. Employment of aircraft and avionics equipment mechanics and technicians is projected to show little or no change from 2012 to 2022. Job prospects will be best for mechanics who hold an Airframe and Powerplant (A&P) certificate.

Mobile offers global aviation leaders the right combination of low business costs, skilled labor force in a rightto-work state and intermodal access to national and international markets. Industry companies including Air bus, Continental Motors and VT MAE continue to expand with commitment to the community. Mobile area aviation and aerospace companies employ an estimated 3,500 engineers, processors, mechanics, welders and other skilled workers, forming an ever-growing labor market.

An Advanced Composite program is currently under development.

Distance Education

All of the General Education requirements can be met via online courses if necessary. Due to the nature of the program, classroom time is spent between theory and hands-on lab work. The program will be taught in a traditional classroom/lab environment.

Collaboration and Similar Programs

Discussions are being held with Auburn University regarding a 2+2 agreement with the University's College of Business in Professional Flight Management and Aviation Management. This program is currently being offered at the Alabama Aviation Center in Ozark. Ozark is approximately 151 miles from Brookley Field in Mobile.

Resources

Faculty

There are currently five full-time faculty and four part-time faculty employed. There are no plans to add faculty at this time.

Equipment

Current equipment in place is adequate for the program. See attached list of equipment.

Facilities

The current facility is adequate for this program. Alabama Aviation Center is located at the Brookley Complex in Mobile. A 37,200 square foot, centrally heated and cooled building with 110 and 220 electrical access contains the following areas: administrative/student services, a learning resources center, bookstore, nine classrooms, four Airframe Systems labs, two reciprocating engine labs, two turbine engine labs, two sheet metal labs, a full welding lab, a composite lab, a battery lab, an NDI lab, a computer lab, 12 offices for instructors and two student lounges. The facility has the capacity for 180 students. A hangar facility is located approximately 2 miles from the classroom area. The hangar facility is connected to the Brookley Complex runway via taxiways.

Library

Library holdings are adequate to support the program. However, additional resources may be purchased to meet FAA requirements. Library offerings are reviewed annually and faculty input is solicited to update and maintain the College collection

MEMORANDUM OF UNDERSTANDING AND STATEMENT OF INTENT TO RE-ALIGN SOUTH ALABAMA AVIATION SITES OF ENTERPRISE STATE COMMUNITY COLLEGE AVIATION PROGRAM TO FAULKNER STATE COMMUNITY COLLEGE

Whereas, pursuant to Alabama Act No. 2015-125 (the "Act") the Alabama Aviation College was established as an independent institution within the Alabama Community College System under the direct authority and responsibility of the Chancellor of the Alabama Community College System and is responsible for providing aviation education and training statewide; and,

Whereas, the Chancellor, pursuant to the Act, is responsible for ensuring that programs and curriculum provided by the Aviation College are aligned with the needs of the aviation industry; and,

Whereas, the Chancellor is expressly authorized by the Act to establish a site or branch of the Aviation College, whether permanent or temporary, to fulfill the statewide aviation education mission of the Alabama Community College System; and,

Whereas, Enterprise State Community College ("Enterprise State"), located in Enterprise, Coffee County, Alabama currently operates and administers the aviation programs located on a Mobile, Alabama campus that is located just off Interstate 10 at the Brookley Aeroplex on the western shore of Mobile Bay and offers aviation courses at a newly constructed education training center located in Baldwin County, Alabama at the Fairhope Airport (collectively the "South Alabama Aviation Sites"). Aviation instruction and training programs being offered at the Mobile campus include Airframe, Powerplant (A&P), and Avionics. An Advanced Composite Program is also under development; and,

Whereas, the South Alabama Aviation Sites are centrally located in close proximity to several United States military training centers located along the Alabama and Florida gulf coast and the aviation programs offered across the region enhance our nation's ability to provide national security and pursue international initiatives. The aviation industry in the Alabama Gulf Coast region is sound and growing and there are numerous aerospace employment opportunities within a 60 mile radius of the South Alabama Aviation Sites; and,

Whereas, the Chancellor has studied and reviewed the Alabama Aviation College's programmatic, financial, and instructional needs and partnership opportunities with business and industry and has determined that the South Alabama Aviation Sites program administration will be enhanced and better fulfil the mandates and directives of the Act if they are re-aligned and

managed under his direction through Faulkner State Community College ("Faulkner State") located in Baldwin County, Alabama; and,

Whereas, Faulkner State and its President are committed to assuming the responsibility for the South Alabama Aviation Sites pursuant to the Act and providing the leadership, funding and management expertise to ensure a quality aviation program is maintained in South Alabama that addresses the needs of the growing aviation business and industry segments;

NOW THEREFORE, pursuant to the direction of the Chancellor of the Alabama Community College System and by mutual agreement and understanding by and between Enterprise State and Faulkner State, the parties have reached a common understanding that it is in the best interests of the general public to formally re-align the South Alabama Aviation Sites training and instructional programs currently operated and administered by Enterprise State Community College with Faulkner State under the Chancellor's direction in order to fulfill the statewide aviation education mission of the Alabama Community College System. It is acknowledged that in order to implement, promote, and effect such a re-alignment, proper approval must be sought and gained from the appropriate regulatory and accrediting agencies, including the Alabama Commission on Higher Education (ACHE), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Federal Aviation Administration (FAA), and the U.S. Department of Education. In addition, the following actions, agreements, and commitments will be required:

- 1. <u>Personnel</u>. It is expressly understood that all South Alabama Aviation Site based aviation personnel currently assigned to Enterprise State Community College, as reflected by the official payroll and personnel records of Enterprise State, shall become employees of Faulkner State, retaining all rights, privileges, and benefits previously granted to them as employees of Enterprise State. Enterprise State shall provide Faulkner State with all personnel and human resource files pertaining to the transferred employees.
- 2. <u>Budget/Fiscal Management</u>. It is the intent of the parties that, subject to the authority of the Chancellor, Faulkner State shall become solely responsible for the aviation programs and operational budget, management of assets, and personnel obligations at the Aviation College's South Alabama Aviation Sites. In cooperation with the Chancellor, Faulkner State shall assume responsibility for the South Alabama Aviation Sites budgets and legislative appropriations.
- 3. <u>Accreditation/Standards</u>. Pursuant to the terms and conditions of this memorandum and agreement, the Chancellor and Faulkner State shall cooperate to establish and maintain all professional and regulatory standards and accreditation applicable to the South Alabama Aviation Sites aviation programs, including but not limited to FAA required certifications. Faulkner State will maintain regional accreditation with the Southerm Association of Colleges and Schools Commission on Colleges (SACSCOC). Enterprise State shall provide Faulkner State with copies of Enterprise State's accreditation audit reports and any corrective action plans for fiscal years 2012-2013 and 2013-2014 that

may impact the aviation programs being re-aligned pursuant to the terms of this memorandum and agreement.

- 4. Land, Equipment and Facilities. In furtherance of the re-alignment, Faulkner State shall assume responsibility and Enterprise State shall, to the extent necessary, transfer and/or assign to Faulkner State all real estate, buildings, leases, licenses, contracts and equipment utilized or maintained for the provision of the South Alabama Aviation Sites aviation programs. If required, Faulkner State may enter into an appropriate sub-lease agreement with Enterprise State, which may provide for the continued use and availability of program and training space and facilities on the South Alabama Aviation Sites. Enterprise State, in cooperation with the Chancellor, shall provide Faulkner State an inventory listing and copies of all pertinent and material contracts applicable to such real estate, equipment and facilities, including warranties, manuals, deeds, leases maintenance schedules, insurance certificates or documents of any description applicable to the land, equipment or buildings transferred pursuant to this provision.
- 5. <u>Audit</u>. Enterprise State shall provide Faulkner State with copies of Enterprise State's Public Examiners Audit reports and any corrective action plans for fiscal years 2012-2013 and 2013-2014.
- 6. Name of Separated Entity/Programs. The Act, subject to certain specific authority reserved to the Alabama Community College System's Board of Trustees, vests and authorizes the Chancellor with the responsibility and management of any public two-year institution. Upon the formal re-alignment of the South Alabama Aviation Sites aviation programs, Enterprise State will have no authority for offering aviation courses at the applicable sites. Following the re-alignment, it is the Chancellor's directive that the Alabama Aviation College's South Alabama Aviation Sites program sites shall be designated "The Alabama Aviation College at Faulkner State Community College". Faulkner State will provide comprehensive aviation training services to the community and area served including strengthened vocational and technical degree or certificate programs; adult learning opportunities; civic, social, cultural, and personal development opportunities; business and industry training opportunities; and active involvement and support of economic development.
- 7. <u>Students</u>. - 8. <u>Administrative Staff</u>. The vacant Director's position for the South Alabama Aviation Sites shall be mutually agreed upon by the Chancellor and the President of Faulkner State. Such staff shall engage from time to time in planned professional aviation

development programs designed to support and enhance the development of a comprehensive community college aviation instructional and training program.

- 9. <u>Miscellaneous</u>. Enterprise State and Faulkner State will cooperate with the Chancellor to resolve and affect all matters reasonably necessary to accomplish this transition and realignment, including certifying a list of assets, confirming personnel, compiling inventory listings, providing for computer and technology services, resolving any and all public utility issues, and other administrative matters related to transition. The Chancellor will require that the colleges make full disclosure of any and all commitments and obligations which may impact the Alabama Aviation College or Faulkner State and/or the Alabama Community College System, and Enterprise State will cooperate in the resolution of such matters. The Chancellor will approve all transition plans, monitor the actions taken, evaluate their effectiveness, and report annually to the Alabama Community College's Board of Trustees on the progress made. This report will be made for at least the next three years and will include fiscal accountability, program accountability, and administrative accountability.
- <u>Effective Date</u>. The process for re-alignment of the South Alabama Aviation Sites programs, including the pursuit of appropriate regulatory and accreditation approvals, will commence with the signing of this Memorandum of Understanding by all parties.

RATIONALE

On August 12, 2015, the Board of Trustees approved Brookley Field in Mobile as an instructional site for Faulkner State Community College. Approval of the site was the first step in the process for the South Alabama Aviation Sites re-alignment for Faulkner State.

The next step in this process is the approval of an Associate in Applied Science Degree and Certificate Award in Avionics Technology. This is an existing program at Brookley Field and is currently offered by Enterprise State Community College. Approval of this program for Faulkner State Community College will assure continuity for students currently enrolled in the Avionics Technology program.

The College projects that a total of \$943,210 in estimated new funds will be required to support the proposed program, and a total of \$1,050,995 will be available through internal allocations, tuition, and extramural funds. The Alabama Commission on Higher Education approved this program on September 11, 2015. More detailed information regarding this program follows this recommendation.

Faulkner State Community College Associate in Applied Science and Certificate in Avionics Technology

Program Description:

A program that prepares individuals to apply technical knowledge and skills to repair, service, and maintain all aircraft operating, control, and electronic systems. Includes instruction in flight instrumentation, aircraft communications and homing systems, radar and other sensory systems, navigation aids, and specialized systems for various types of civilian and military aircraft.

Program Objectives:

Along with the Avionics Technology degree the student will also receive a variety of employability skills and work ethics that will allow him/her to be competitive in other elements of the aviation industry. Graduates of the program will be prepared to take the Federal Communications Commission (FCC) General Radiotelephone Operator License examination.

After completion of the second semester, an Aircraft Electronics Technician (AET) certification, by the National Center for Aerospace & Transportation Technologies (NCATT);

After completion of the second semester, students may take the FCC General Radio Operators License exam, Elements 1 and 3 to become certified for Radio Operation and Repair;

After completion of the fourth semester, NCATT Endorsement Certifications in Onboard Communication & Safety Systems and Radio Communication Systems;

At the end of the fourth semester, the student may test for Institute of Printed Circuits (IPAC) IPC/WHMA-A-6208 Requirements and Acceptance for Cable and Wire Harness Assemblies Certification;

At the end of the fourth semester, students may take the FCC General Radio Operators License, Element 8 (Radar) exam to become certified for Radar Operation and Repair;

After completion of the fifth semester, students may take NCATT Endorsement Certifications in Autonomous Navigation Systems, Dependent Navigation Systems.

To assess the program, a program review will be undertaken. The program review will consist of Level I and Level II reviews and may include Level III reviews. The Level I review of all programs is conducted by the Alabama Community College System. The Level II review is a complete review of the program by the College. Level I reviews processed by the Alabama Community College System may identify a program for Level II review at an earlier date than indicated by its assigned sequence. A Level III review is a system-wide review of a specific instructional program or programs initiated by the Chancellor and predicated upon the findings of instructional program reviews at Levels I and II. An advisory committee with representation from organizations being served by the program graduates will be utilized to periodically review the program's curriculum and advise the program on the establishment, review, and revision of the program objectives. The advisory committee will provide advisement on current and future aspects of the technical field for which the graduates are being prepared.

Program Need:

Pursuant to Alabama Act No. 2015-125, the Alabama Aviation College was established as an independent institution within the Alabama Community College System for providing aviation education and training statewide. Enterprise State Community College currently operates and administers the aviation programs located at Brookley Field in Mobile and at the Fairhope Airport (collectively referred to as the South Alabama Aviation Sites).

A review of the Alabama Aviation College's programmatic, financial, and instructional needs and partnership opportunities has determined that the South Alabama Aviation Sites program administration will be enhanced and better fulfill the mandates and directives of the Act if they are re-aligned and managed under the direction of Faulkner State Community College. In order to implement, promote, and effect such a re-alignment, proper approval will be sought and gained from the appropriate regulatory and accrediting agencies, including the Alabama Commission on Higher Education (ACHE), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Federal Aviation Administration (FAA), and the U.S. Department of Education. In the spirit of cooperation, the presidents of Enterprise State Community College are in agreement and signed the attached Memorandum of Understanding.

The Avionics Technology program is an existing program at Brookley Field-Mobile.

Projected Job Openings:

Established in 1976, the Mobile campus is located just off Interstate 10 at the Brookley Aeroplex on the western shore of Mobile Bay. It is close to the United States Coast Guard Aviation Training Center, within 40 miles of the Pensacola Naval Air Station, the primary training base for Navy and Marine aviation, and is near Eglin Air Force Base, Tyndall Air Force Base, and Keesler Air Force Base. The aviation programs offered across the AAC regions enhance our nation's ability to provide national security and pursue international initiatives.

There are numerous aerospace employment opportunities within a 60 mile radius of the Mobile campus. Companies include, United Technologies, Segers Aero Corporation, Airbus Military, Continental Motors, ST Aerospace, Star Aviation, PHI Helicopter Inc., Southern Avionics, and the new Airbus Final Assembly Line.

Employment of aircraft mechanics and technicians is projected to show little or no change from 2012 to 2022. Job prospects are best for mechanics holding an Airframe credential. In May 2012, the median annual wage for aircraft mechanics and service technicians was \$55,210.

Aircraft mechanics and avionics technicians held about 138,900 jobs in 2012. Approximately 88 percent were aircraft mechanics. The majority worked for private companies and about 14 percent worked for the federal government.

Brookley Field, an expanding aerospace industry hub, captured the global business spotlight recently when Airbus selected Mobile for its only assembly site in the western hemisphere. Construction has been completed on this \$600 million project and the first deliveries are expected in 2016. Employment of aircraft and avionics equipment mechanics and technicians is projected to show little or no change from 2012 to 2022. Job prospects will be best for mechanics who hold an Airframe and Powerplant (A&P) certificate.

Mobile offers global aviation leaders the right combination of low business costs, skilled labor force in a right-to-work state and intermodal access to national and international markets. Industry companies including Air bus, Continental Motors and VT MAE continue to expand with commitment to the community. Mobile

area aviation and aerospace companies employ an estimated 3,500 engineers, processors, mechanics, welders and other skilled workers, forming an ever-growing labor market.

Whereas, the Chancellor is expressly authorized by the Act to establish a site or branch of the Aviation College, whether permanent or temporary, to fulfill the statewide aviation education mission of the Alabama Community College System; and,

Whereas, Enterprise State Community College ("Enterprise State"), located in Enterprise, Coffee County, Alabama currently operates and administers the aviation programs located on a Mobile, Alabama campus that is located just off Interstate 10 at the Brookley Aeroplex on the western shore of Mobile Bay and offers aviation courses at a newly constructed education training center located in Baldwin County, Alabama at the Fairhope Airport (collectively the "South Alabama Aviation Sites"). Aviation instruction and training programs being offered at the Mobile campus include Airframe, Powerplant (A&P), and Avionics. An Advanced Composite Program is also under development; and,

Whereas, the South Alabama Aviation Sites are centrally located in close proximity to several United States military training centers located along the Alabama and Florida gulf coast and the aviation programs offered across the region enhance our nation's ability to provide national security and pursue international initiatives. Faulkner State Community College Associate in Applied Science and Certificate in Powerplant Technology

Program Description:

This program is designed to prepare students to apply technical knowledge and skills to repair, service, and maintain all types of aircraft powerplant and related systems. The program will prepare students to the take Federal Aviation Administration (FAA) written, oral, and practical examinations required for certification.

Program Objectives:

Along with the Powerplant Technology degree the student will also receive a variety of employability skills and work ethics that will allow him/her to be competitive in other elements of the aviation industry.

This program begins with a broad-based approach to the study of electronics to prepare students with a basic knowledge of electronic theory and a working knowledge of electronics equipment and components. Beyond initial instruction in those areas, students receive extensive, hands-on training with aviation electronics equipment such as communication and navigation radios, weather radars, autopilots, on-board computers, transponders and more.

FAA certification is normally required to begin a career as a powerplant maintenance technician. These technicians are in high demand by regional and national commercial airlines, in general aviation, and in support of the military and other governmental agencies that use aircraft.

To assess the program, a program review will be undertaken. The program review will consist of Level I and Level II reviews and may include Level III reviews. The Level I review of all programs is conducted by the Alabama Community College System. The Level II review is a complete review of the program by the College. Level I reviews processed by the Alabama Community College System may identify a program for Level II review at an earlier date than indicated by its assigned sequence. A Level III review is a system-wide review of a specific instructional program or programs initiated by the Chancellor and predicated upon the findings of instructional program reviews at Levels I and II. An advisory committee with representation from organizations being served by the program graduates will be utilized to periodically review the program's curriculum and advise the program on the establishment, review, and revision of the program objectives. The advisory committee will provide advisement on current and future aspects of the technical field for which the graduates are being prepared.

Program Need:

Pursuant to Alabama Act No. 2015-125, the Alabama Aviation College was established as an independent institution within the Alabama Community College System for providing aviation education and training statewide. Enterprise State Community College currently operates and administers the aviation programs located at Brookley Field in Mobile and at the Fairhope Airport (collectively referred to as the South Alabama Aviation Sites).

A review of the Alabama Aviation College's programmatic, financial, and instructional needs and partnership opportunities has determined that the South Alabama Aviation Sites program administration will be enhanced and better fulfill the mandates and directives of the Act if they are re-aligned and managed under the direction of Faulkner State Community College. In order to implement, promote, and effect such a re-alignment, proper approval will be sought and gained from the appropriate regulatory and accrediting agencies, including the Alabama Commission on Higher Education (ACHE), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Federal Aviation Administration (FAA), and the U.S. Department of Education. In the spirit of cooperation, the presidents of Enterprise State Community College and Faulkner State Community College are in agreement and signed the attached Memorandum of Understanding.

The Powerplant Technology program is an existing program at Brookley Field-Mobile.

Projected Job Openings:

Established in 1976, the Mobile campus is located just off Interstate 10 at the Brookley Aeroplex on the western shore of Mobile Bay. It is close to the United States Coast Guard Aviation Training Center, within 40 miles of the Pensacola Naval Air Station, the primary training base for Navy and Marine aviation, and is near Eglin Air Force Base, Tyndall Air Force Base, and Keesler Air Force Base. The aviation programs offered across the AAC regions enhance our nation's ability to provide national security and pursue international initiatives.

There are numerous aerospace employment opportunities within a 60 mile radius of the Mobile campus. Companies include, United Technologies, Segers Aero Corporation, Airbus Military, Continental Motors, ST Aerospace, Star Aviation, PHI Helicopter Inc., Southern Avionics, and the new Airbus Final Assembly Line.

Employment of aircraft mechanics and technicians is projected to show little or no change from 2012 to 2022. Job prospects are best for mechanics holding an Airframe credential. In May 2012, the median annual wage for aircraft mechanics and service technicians was \$55,210.

Aircraft mechanics and avionics technicians held about 138,900 jobs in 2012. Approximately 88 percent were aircraft mechanics. The majority worked for private companies and about 14 percent worked for the federal government.

Brookley Field, an expanding aerospace industry hub, captured the global business spotlight recently when Airbus selected Mobile for its only assembly site in the western hemisphere. Construction has been completed on this \$600 million project and the first deliveries are expected in 2016. Employment of aircraft and avionics equipment mechanics and technicians is projected to show little or no change from 2012 to 2022. Job prospects will be best for mechanics who hold an Airframe and Powerplant (A&P) certificate.

Mobile offers global aviation leaders the right combination of low business costs, skilled labor force in a right-to-work state and intermodal access to national and international markets. Industry companies including Air bus, Continental Motors and VT MAE continue to expand with commitment to the community. Mobile area aviation and aerospace companies employ an estimated 3,500 engineers, processors, mechanics, welders and other skilled workers, forming an ever-growing labor market.

An Advanced Composite program is currently under development.

Distance Education

All of the General Education requirements can be met via online courses if necessary. Due to the nature of the program, classroom time is spent between theory and hands-on lab work. The program will be taught in a traditional classroom/lab environment.

Collaboration and Similar Programs

Discussions are being held with Auburn University regarding a 2+2 agreement with the University's College of Business in Professional Flight Management and Aviation Management. This program is currently being offered at the Alabama Aviation Center in Ozark. Ozark is approximately 151 miles from Brookley Field in Mobile.

Resources

Faculty

There are currently four full-time faculty employed. There are no plans to add faculty at this time.

Equipment

Current equipment in place is adequate for the program. See attached list of equipment.

Facilities

The current facility is adequate for this program. Alabama Aviation Center is located at the Brookley Complex in Mobile. A 37,200 square foot, centrally heated and cooled building with 110 and 220 electrical access contains the following areas: administrative/student services, a learning resources center, bookstore, nine classrooms, four Airframe Systems labs, two reciprocating engine labs, two turbine engine labs, two sheet metal labs, a full welding lab, a composite lab, a battery lab, an NDI lab, a computer lab, 12 offices for instructors and two student lounges. The facility has the capacity for 180 students. A hangar facility is

located approximately 2 miles from the classroom area. The hangar facility is connected to the Brookley Complex runway via taxiways.

<u>Library</u>

Library holdings are adequate to support the program. However, additional resources may be purchased to meet FAA requirements. Library offerings are reviewed annually and faculty input is solicited to update and maintain the College collection.

MEMORANDUM OF UNDERSTANDING AND STATEMENT OF INTENT TO RE-ALIGN SOUTH ALABAMA AVIATION SITES OF ENTERPRISE STATE COMMUNITY COLLEGE AVIATION PROGRAM TO FAULKNER STATE COMMUNITY COLLEGE

Whereas, pursuant to Alabama Act No. 2015-125 (the "Act") the Alabama Aviation College was established as an independent institution within the Alabama Community College System under the direct authority and responsibility of the Chancellor of the Alabama Community College System and is responsible for providing aviation education and training statewide; and,

Whereas, the Chancellor, pursuant to the Act, is responsible for ensuring that programs and curriculum provided by the Aviation College are aligned with the needs of the aviation industry; and,

Whereas, the Chancellor is expressly authorized by the Act to establish a site or branch of the Aviation College, whether permanent or temporary, to fulfill the statewide aviation education mission of the Alabama Community College System; and,

Whereas, Enterprise State Community College ("Enterprise State"), located in Enterprise, Coffee County, Alabama currently operates and administers the aviation programs located on a Mobile, Alabama campus that is located just off Interstate 10 at the Brookley Aeroplex on the western shore of Mobile Bay and offers aviation courses at a newly constructed education training center located in Baldwin County, Alabama at the Fairhope Airport (collectively the "South Alabama Aviation Sites"). Aviation instruction and training programs being offered at the Mobile campus include Airframe, Powerplant (A&P), and Avionics. An Advanced Composite Program is also under development; and,

Whereas, the South Alabama Aviation Sites are centrally located in close proximity to several United States military training centers located along the Alabama and Florida gulf coast and the aviation programs offered across the region enhance our nation's ability to provide national security and pursue international initiatives. The aviation industry in the Alabama Gulf Coast region is sound and growing and there are numerous aerospace employment opportunities within a 60 mile radius of the South Alabama Aviation Sites; and,

Whereas, the Chancellor has studied and reviewed the Alabama Aviation College's programmatic, financial, and instructional needs and partnership opportunities with business and industry and has determined that the South Alabama Aviation Sites program administration will be enhanced and better fulfil the mandates and directives of the Act if they are re-aligned and

managed under his direction through Faulkner State Community College ("Faulkner State") located in Baldwin County, Alabama; and,

Whereas, Faulkner State and its President are committed to assuming the responsibility for the South Alabama Aviation Sites pursuant to the Act and providing the leadership, funding and management expertise to ensure a quality aviation program is maintained in South Alabama that addresses the needs of the growing aviation business and industry segments;

NOW THEREFORE, pursuant to the direction of the Chancellor of the Alabama Community College System and by mutual agreement and understanding by and between Enterprise State and Faulkner State, the parties have reached a common understanding that it is in the best interests of the general public to formally re-align the South Alabama Aviation Sites training and instructional programs currently operated and administered by Enterprise State Community College with Faulkner State under the Chancellor's direction in order to fulfill the statewide aviation education mission of the Alabama Community College System. It is acknowledged that in order to implement, promote, and effect such a re-alignment, proper approval must be sought and gained from the appropriate regulatory and accrediting agencies, including the Alabama Commission on Higher Education (ACHE), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Federal Aviation Administration (FAA), and the U.S. Department of Education. In addition, the following actions, agreements, and commitments will be required:

- 1. <u>Personnel</u>. It is expressly understood that all South Alabama Aviation Site based aviation personnel currently assigned to Enterprise State Community College, as reflected by the official payroll and personnel records of Enterprise State, shall become employees of Faulkner State, retaining all rights, privileges, and benefits previously granted to them as employees of Enterprise State. Enterprise State shall provide Faulkner State with all personnel and human resource files pertaining to the transferred employees.
- <u>Budget/Fiscal Management</u>. It is the intent of the parties that, subject to the authority of the Chancellor, Faulkner State shall become solely responsible for the aviation programs and operational budget, management of assets, and personnel obligations at the Aviation College's South Alabama Aviation Sites. In cooperation with the Chancellor, Faulkner State shall assume responsibility for the South Alabama Aviation Sites budgets and legislative appropriations.
- 3. <u>Accreditation/Standards</u>. Pursuant to the terms and conditions of this memorandum and agreement, the Chancellor and Faulkner State shall cooperate to establish and maintain all professional and regulatory standards and accreditation applicable to the South Alabama Aviation Sites aviation programs, including but not limited to FAA required certifications. Faulkner State will maintain regional accreditation with the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). Enterprise State shall provide Faulkner State with copies of Enterprise State's accreditation audit reports and any corrective action plans for fiscal years 2012-2013 and 2013-2014 that

may impact the aviation programs being re-aligned pursuant to the terms of this memorandum and agreement.

- 4. Land, Equipment and Facilities. In furtherance of the re-alignment, Faulkner State shall assume responsibility and Enterprise State shall, to the extent necessary, transfer and/or assign to Faulkner State all real estate, buildings, leases, licenses, contracts and equipment utilized or maintained for the provision of the South Alabama Aviation Sites aviation programs. If required, Faulkner State may enter into an appropriate sub-lease agreement with Enterprise State, which may provide for the continued use and availability of program and training space and facilities on the South Alabama Aviation Sites. Enterprise State, in cooperation with the Chancellor, shall provide Faulkner State an inventory listing and copies of all pertinent and material contracts applicable to such real estate, equipment and facilities, including warranties, manuals, deeds, leases maintenance schedules, insurance certificates or documents of any description applicable to the land, equipment or buildings transferred pursuant to this provision.
- 5. <u>Audit</u>. Enterprise State shall provide Faulkner State with copies of Enterprise State's Public Examiners Audit reports and any corrective action plans for fiscal years 2012-2013 and 2013-2014.
- 6. Name of Separated Entity/Programs. The Act, subject to certain specific authority reserved to the Alabama Community College System's Board of Trustees, vests and authorizes the Chancellor with the responsibility and management of any public two-year institution. Upon the formal re-alignment of the South Alabama Aviation Sites aviation programs, Enterprise State will have no authority for offering aviation courses at the applicable sites. Following the re-alignment, it is the Chancellor's directive that the Alabama Aviation College's South Alabama Aviation Sites program sites shall be designated "The Alabama Aviation College at Faulkner State Community College". Faulkner State will provide comprehensive aviation training services to the community and area served including strengthened vocational and technical degree or certificate programs; adult learning opportunities; civic, social, cultural, and personal development opportunities; business and industry training opportunities; and active involvement and support of economic development.
- 7. <u>Students</u>. It is the intent of the parties that all students currently enrolled in Enterprise State's aviation programs at the South Alabama Aviation Sites will be permitted to complete their programs under the same terms, conditions, understandings, and assurances they received upon entering their current program of study. Student related services and provisions will be transitional, as appropriate. Full execution of the student related re-alignment will be pending based on receipt of required ACHE, SACSCOC, FAA and U.S. Department of Education approvals.
- 8. <u>Administrative Staff</u>. The vacant Director's position for the South Alabama Aviation Sites shall be mutually agreed upon by the Chancellor and the President of Faulkner State. Such staff shall engage from time to time in planned professional aviation

development programs designed to support and enhance the development of a comprehensive community college aviation instructional and training program.

- 9. <u>Miscellaneous</u>. Enterprise State and Faulkner State will cooperate with the Chancellor to resolve and affect all matters reasonably necessary to accomplish this transition and realignment, including certifying a list of assets, confirming personnel, compiling inventory listings, providing for computer and technology services, resolving any and all public utility issues, and other administrative matters related to transition. The Chancellor will require that the colleges make full disclosure of any and all commitments and obligations which may impact the Alabama Aviation College or Faulkner State and/or the Alabama Community College System, and Enterprise State will cooperate in the resolution of such matters. The Chancellor will approve all transition plans, monitor the actions taken, evaluate their effectiveness, and report annually to the Alabama Community College's Board of Trustees on the progress made. This report will be made for at least the next three years and will include fiscal accountability, program accountability, and administrative accountability.
- 10. <u>Effective Date</u>. The process for re-alignment of the South Alabama Aviation Sites programs, including the pursuit of appropriate regulatory and accreditation approvals, will commence with the signing of this Memorandum of Understanding by all parties.

After receipt of bids for the HVAC project, additional authorization is requested to increase the budget to \$980,862. The additional \$140,605 will be paid from remaining Revenue Bond funds.

Memorandum of Understanding Between Snead State Community College and Wallace State Hanceville Community College

This Memorandum of Understanding (the Memorandum) is made on this day, July 10, 2015, by and between Snead State Community College, 102 Elder Street, Boaz, AL 35957, hereinafter referred to as Snead and Wallace State Community College, 801 Main Street NW, Hanceville, AL 36116, hereinafter referred to as Wallace State for the purpose of stating intent and achieving objectives relating to the shared service area of the City of Oneonta and providing educational services from the Wallace State Higher Education Center established by the City of Oneonta.

PURPOSE: The purpose of this Memorandum is to provide a framework for current and future agreements regarding providing educational services within the City of Oneonta and does not change the manner in which Adult Education is currently provided in the City of Oneonta.

WHEREAS Snead President Robert Exley and Wallace State President Vicki Karolewics have engaged in a collaborative effort to establish comprehensive postsecondary educational opportunities at each respective College, and agree that it is appropriate for Wallace State to establish as one of its sites the Wallace State Higher Education Center at which instructional and related services will be provided. As a result of this collaborative effort comprehensive educational services will commence involving the Wallace State Higher Education Center upon its completion.

WHEREAS Wallace State is currently SACSCOC accredited and therefore prepared and confirmed to offer a full range of course offerings in the City of Oneonta.

WHEREAS Snead and Wallace State agree that both parties are currently committed to Wallace State utilizing the Wallace State Higher Education Center to provide educational services to students in the City of Oneonta. Wallace State will begin to provide educational services to students in the City of Oneonta through the Wallace State Higher Education Center at the earliest possible date.

OBLIGATIONS: Snead and Wallace State acknowledge that no contractual relationship is created between them by this Memorandum, but agree to work together in the true spirit of partnership to ensure united and responsive leadership while providing educational services to the students in the City of Oneonta. Snead and Wallace State desire to enter into this agreement in which they collaboratively provide educational opportunities to the students in the City of Oneonta and will work together to meet this stated outcome. As such, this MOU may be revised during the academic year with the agreement of both parties.

By signing this MOU, the parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a party found to be in violation of this provision shall be deemed in breach of the MOU and shall be responsible for all damages resulting therefrom.

It is recommended "That the Alabama Community College System Board of Trustees approve the 2015-2016 budgets as presented by the Chancellor for the community and technical colleges, Alabama Technology Network (ATN) and Marion Military Institute (MMI)."

FISCAL CONSIDERATION

The total 2015-2016 projected revenues for the twenty-five community and technical colleges, Marion Military Institute and the Alabama Technology Network is \$915,187,530. Revenues for the colleges and Marion Military Institute are comprised of State Education Trust Fund (ETF) appropriations, estimated fee collections, auxiliary enterprise operations, estimated Federal, State, and local grants and contracts, and other miscellaneous income. The ATN revenues include the ETF funding, and projections for Federal and State grants and other miscellaneous income.

RATIONALE

Each entity of the Alabama Community College System has prepared and submitted a budget for its annual operation based on various revenue sources for the fiscal year 2015-2016. The approval of the budgets will allow the institutions and entities of the System to continue operation into the 2015-2016 fiscal year.

Revenue sources available for the ATN and MMI for 2015-2016 general operations, with prior year figures, are as follows:

The primary source of revenues for the community and technical colleges include State appropriations and tuition and fees. Of the total revenues projected, tuition and fees represent 30.89 percent and federal funds account for 29.07 percent. Student Aid funds comprise a total of 75.62 percent of the Federal funds awarded.

Expenditures budgeted by the ATN and MMI for 2015-2016, with prior year figures, are as follows:

State teachers' retirement benefit rates increased from 11.71% to 11.94% for Tier 1 employees and decreased from 11.05% to 10.84% for Tier II employees. Public Education Employees' Health Insurance Plan costs remained level at \$780 per month.

Plant revenues and expenditures have been excluded from the calculations as most Plant activities are funded with internal transfers from previously reported fund sources.

Fifteen colleges in the Alabama Community College System are projecting a three-month or more contingency balance in the current unrestricted fund and the unexpended plant fund with ten more projecting the two-month contingency that is required by the Chancellor. Contingency balance indicates the number of months the institution's available fund balance would pay current unrestricted expenditures, including mandatory transfers, in the event of emergency situations.

RECOMMENDATION

It is recommended "That the Alabama Community College System Board of Trustees approve the 2015-2016 budget for the Alabama Community College System Office and limit expenditures to available revenues."

FISCAL CONSIDERATION

The total amount of the 2015-2016 budget is \$65,591,451 based on state appropriations, estimated federal grants and contracts, and estimated fee collections.

RATIONALE

The Chancellor has prepared the budget for the annual operation of the System Office so as to comply with State statute requiring Board of Trustees approval of the budget. Revenue and expenditure details are presented below.

The annual operations budget is based on the State appropriation for the Alabama Community College System's Administration, Industry Certification Initiatives, Special Populations Training, and Dual Enrollment. A State appropriation and Federal grant are available for the Adult Education administration and services. A Federal grant from the Carl D. Perkins Vocational and Technical Education Act funds vocational education administration and leadership. A Federal grant through the Alabama Department of Human Resources provides funds for administration of an educational scholarship program for childcare center directors, teachers, and home providers. The Department of Veteran's Affairs Education Service provides funds to support veterans' educational activities through our State Approving Agency. The Private School Licensure and Alabama General Education Diploma programs generate fees to fund their operations.

Leslie and her husband, David, live in Montgomery, have two children, and are members of St. James United Methodist Church.

Mr. William F. "Noopie" Cosby, Jr. is the owner of The Cosby Company. Mr. Cosby attended MMI and earned an Associate's Degree in 1969. He earned a Bachelor's Degree from the University of West Alabama in 1974. He served in the Alabama House of Representatives from 1978 to 1994. Mr. Cosby founded The Cosby Company, a government affairs and public relations agency, in 1994, and ran the Cosby Ice Company from 1987 to 2013. He served as the City of Selma Administrator of Comprehensive Employment Training Act (CETA) from 1976 to 1978. He also worked as a junior high and high school football coach and social studies teacher in 1976 in the Thomasville City School System. Noopie is a native of Selma, Alabama. He and his wife, Susan, have five children and five grandchildren. Noopie is a deacon at the First Baptist Church of Selma.

ACT #2006-230 stipulates that, "the MMI board shall recommend to the Chancellor, for appointment by the Alabama State Board of Education, qualified persons for appointment or reappointment to the board." SHELTON STATE COMMUNITY COLLEGE Donation of Land

RECOMMENDATION

It is recommended "That the Alabama Community College System Board of Trustees authorize the President of Shelton State Community College ("Shelton State" or College"), to accept on behalf of the Board of Trustees of the Alabama Community College System ("Board") an outright donation of approximately six acres of land ("Property") located within the South Industrial Park of the City of Demopolis ("City") from the Demopolis Industrial Development Board ("DIDB"), pursuant to the substantive terms included in the attached Letter of Intent, dated June 24, 2015, from the DIDB to Shelton State."

FISCAL CONSIDERATION

None.

RATIONALE

The DIDB has agreed to deed the Property to the Board for use by Shelton State for expansion of College services in the City. The DIDB will retain in the warranty deed a reversionary interest in the Property. Title to the Property will revert to the DIDB in the event that Shelton State is not offering any services based within the City.

This transaction is part of a larger effort by Shelton State to expand its service offerings in and around the City. At its March 11, 2015, meeting, the Alabama State Board of Education ("BOE") approved Shelton State's request to add an additional instructional site in the City to meet the needs of the local community including business, industry, and K-12 constituents as requested by local City business and community leaders. This additional instructional site was further approved by the Alabama Commission on Higher Education on or around June 12, 2015.

Presently, Shelton State offers non-credit courses to the public to include dual enrollment services to qualified high school students in the City and in the surrounding area. The College's "for credit" courses are offered at the Demopolis Higher Education Center (the "HE Center"). The College operates in the HE Center through a lease agreement between the College and the City. The College will continue offering education and training services to the community from this location. Shelton State also presently offers commercial truck driver training services in the City. These services are offered at the New Era Plant Building. The College has operated in the New Era Plant Building through a lease agreement between the College and the City. The College will continue offering commercial truck driver training services in the City, but plans to move this offering to the property to be deeded to the Board.

The College also aims to foster a cooperative relationship with the University of West Alabama. The goal will be to make it possible for students in that area to complete associate and bachelor's degree requirements without extensive travel costs.
