BISHOP STATE COMMUNITY COLLEGE

Procurement of the Process Technology Training System

On motion by Mr. Rhone, second by Mr. Shell the Board unanimously authorized the President of Bishop State Community College to purchase an integrated Process Technology Pilot Plant and associated Distributed Control (Room) System (DCS) for its new Advanced Manufacturing Technology Center (AMTC), a state of the art, 80,000 square foot facility approved by the Board of Trustees in 2019. This system will be housed in the 6,000 sq. ft. high bay Process Technology Center laboratory part of the AMTC.

Fiscal Consideration: \$2,350,000 Purchase Amount from Institutional Funds

ENTERPRISE STATE COMMUNITY COLLEGE

Request for Authority to Sell Property to the City of Enterprise for Use as Recreational Facilities

On motion by Mr. Mitchell, second by Mr. Rogers the Board unanimously authorized the Alabama Community College System on behalf of Enterprise State Community College ("Enterprise State") to proceed with the sale of approximately 25 acres of land to the City of Enterprise for the construction of City owned recreational facilities.

Fiscal Consideration: The City of Enterprise will construct a parking area to service the College's baseball/softball complex.

SECTION X CHANCELLOR'S REPORT

Olivier Charles gave an update on the Chancellor's Challenge, Fall 2021 Enrollment and the CRM implementation. The Chancellor's Challenge is a competition with a goal being that each college increase its own growth percentages in the following four categories from Fall Semester 2020 to Fall Semester 2021: new student headcount, credit hour production, retention and total headcount. The colleges are not competing against each other, but against its 2020 numbers. The college with the largest increase wins that category. The winning colleges will be awarded funds to be used for student success initiatives such as a career closet to help students prepare for interviews, a food pantry, a new website or any other appropriate initiative. The winners will be announced at the ACCA conference and will be given a banner to display on campus. Next, Mr.

Charles provided an update on the Fall Semester 2021 enrollment numbers. As of the date of the meeting, enrollment numbers were at 85% of the Fall 2020 Semester numbers. The numbers are trending upwards, but Mr. Charles advised that the next 3 to 4 weeks would be critical to the community college system as that is when approximately 30% to 40% of enrollment comes in. Mr. Charles also advised that several of the colleges are holding vaccination clinics on campus to encourage students to get vaccinated and some are also offering incentives for vaccination. Last, Mr. Charles gave an update on the CRM implementation. Molly Pollard has been hired as the CRM administrator and all colleges have identified someone at each college as a CRM administrator. Target X has held meetings with each of the colleges. Mr. Charles advised that the pilot implementation at Northwest-Shoals is going well and that the project is ahead of schedule for implementation at the remaining institutions. The original projected date for full implementation at Northwest-Shoals had been November 2021, but Mr. Charles hopes of that happening by mid to late October 2021. The CRM administrators from each college will receive a three day training program. The ACCS Marketing Division has prepared emails for each college to send out once the roll out of Target X begins.
