Chancellor Baker requested that Olivier Charles give an update on enrollment status.

Mr. Charles advised that as of October 13, 2020, there were 75,000 students enrolled in ACCS colleges in credit bearing courses. 20 ACCS colleges have seen an increase in enrollment. Headcount is up by 6% or 4700 students. Credit hour production is up by4% which is 28,000 credit hours. FTE is up 4%, which is 1,800 full time equivalencies. Mr. Charles stated that he is excited about the enrollment figures and hopes the Covid recovery continues. Mr. Charles gives 100% of the credit for the enrollment increase to the colleges, the college Presidents, Student Affairs and Academic Departments for focusing on enrollment for the fall. Mr. Charles also advised that the first in-person Target X CRM training started on October 13, 2020 with 85 staff from across the system participating.
