RESTOCKING FEES

A restocking fee is not intended as a penalty or punishment to our customers. Extron does not profit from these charges. The restocking fee is intended to cover a portion of the costs incurred in processing returned items. The costs we incur include:

- 1) Time and materials involved in processing the original order (sales, accounting and shipping departments).
- 2) Time and materials involved in processing the RA and credit (sales, accounting, receiving, and repair departments).
- 3) Production testing and QC: Every product must go back through production for inspection. A product is never put back on the shelf untested.

REPAIR POLICY

Warranty

Extron offers a three-year limited warranty on parts and labor (Extron's internal labor for repairing product) for all powered products. Our speaker line carries a five-year limited warranty. The warranty period commences on shipment date from Extron. Extron cables carry the Extron Cable Performance Warranty: Limited lifetime. Extron cable products will be free from defects in material and workmanship for as long as you or your customer owns the cable.

If you would like to send a product under warranty in for repair, please call 800.633.9876 for a Return Authorization number.

Normal lead time for repairs is 2 to 3 days from receipt of product. The customer must pay the freight charges when shipping repairs to Extron. All repairs will be returned UPS Ground at no charge to the customer. If another shipping method is specified, the customer is responsible for freight charges.

Out of Warranty

Any product that is older than three years is considered "out of warranty". There is an internal schedule of repair fees that are charged based on the product type. The repair fee covers all parts and labor. All freight charges must be charged to the customer on any out of warranty products, regardless if CND or repair. Extron warranties its repairs for 90 days.

The customer must pay the freight charges when shipping repairs to Extron.

Advance Replacements
