ALABAMA COMMUNITY COLLEGE SYSTEM BOARD OF TRUSTEES MINUTES OF THE MEETING HELD ON WEDNESDAY NOVEMBER 13, 2024, 10:00 A.M.

The Alabama Community College System Board of Trustees (also referred to herein as the Board) held a meeting at 10:00 a.m. on Wednesday, November 13, 2024, in the Board Room of the Alabama Community College System building in Montgomery, Alabama. The meeting was called in accordance with Act No. 2015-125.

PRESIDING: MR. GOODRICH ROGERS, CHAIRMAN

The meeting was called to order by Chairman Rogers.

The invocation was delivered by Pastor Gene Kim of Eastmont Baptist Church in Montgomery, followed by the pledge of allegiance.

APPROVAL OF AGENDA

On motion by Mr. Houston, second by Mr. McCartney, the Board of Trustees voted unanimously to approve the agenda.

APPROVAL OF MINUTES

On motion by Mr. Rhone, second by Ms. Gray, the Board voted unanimously to approve the minutes of the October 9, 2024 meeting as presented without discussion.

SECTION VII COLLEGE SPOTLIGHT

Ms. Annette Funderburk, President of J.F. Ingram State Community College, introduced a video showcasing one of their outstanding students. She stated that next year, Ingram State will celebrate 60 years of providing education to Alabama's incarcerated population. In 2022, correctional education was consolidated so that now the entire state is our service area. collaborating with the Department of Corrections, Ingram serves 21 correctional facilities and, collaborating with the Alabama Bureau of Pardons & Paroles, it serves 12 facilities offering Adult Education, Career Technical programming, credentials, and a high school program for offenders 21 and younger. Per Ms. Funderburk, enrollment has increased by 33% this past year to nearly 3,000 students across all locations. Ingram State prepares students to enter the workforce upon release. In 2024, the job placement team worked with 605 second chance employers to place released students in high-wage, high-demand positions. For every \$1 spent on correctional education, there is a \$4-5 savings in correctional costs. Also, providing correctional education is believed to reduce recidivism by 20%.

Ms. Funderburk introduced Ms. Tierra Dent, a welding student, from the Tutwiler campus. With the assistance of the job placement division, Ms. Dent obtained full-time employment with USA Ready Mix in Opelika, AL. She has received accolades from her supervisor, Darius Gamble.

Ms. Dent briefly spoke about her experience with Ingram State and thanked everyone for the opportunity to speak. She stated that Ingram gave her the education and job training she needed to be successful after being released. She is now a Class A CDL driver and has been with USA Ready Mix for over a year and she loves her job. She thanked everyone associated with Ingram State Technical College for making her successful today. She thanked her supervisor, Mr. Darius Gamble, for believing in her. Mr. Gamble spoke briefly on behalf of Ms. Dent and stated that Ingram State has had a great impact on students' lives. He thanked Ingram State and stated that their program is reaping great benefits for both the students and the employers.

Ms. Funderburk further stated that the new Elmore County mega-prison will be completed in May 2026 and will be a 4,000 bed facility with all levels of security. Ingram State will be offering classes in the new prison by Fall 2026.

SECTION XI CHANCELLOR'S REPORT

Ms. Susan Price, Sr. Deputy for System Development & Strategic Advancement / Chief of Staff, spoke briefly on a new collegewide review of the major operations and programs at Wallace Community College in Dothan. The goal is to identify the strengths and opportunities for the college and to capture the voice and need of the communities that it serves. Understanding where the college is today will assist in selecting the individual with the right skill set to serve as the next permanent President. The review is already underway and the peer review team is already at work. It is comprised of experienced professionals from the colleges as well as the System Office. The team's purpose is not to investigate or disrupt, but to learn about the operations of the college and its various programs to identify best practices and opportunities. Areas under review are Organizational Structure, Fiscal Operations, Human Resources, Academics, Student Services, Workforce Development, etc. The team will offer observations and recommendations based on their experience. Ms. Price added that review teams are not new tools and have been used for years. The new team's work is expected to be complete by early 2025.

Per Chancellor Baker, the selecting of a new President at Wallace will be delayed until the review team has had a chance to conduct its work. The goal is to make Wallace Community College in Dothan the best partner in development in that community and to create a plan to move forward.
