The Alabama Community College System Board of Trustees (also referred to herein as the Board) held a meeting at 10:00 a.m. on Wednesday, September 10, 2025, in the Board Room of the Alabama Community College System building in Montgomery, Alabama. The meeting was called in accordance with Act No. 2015-125.

The meeting was called to order by Chairperson Gray.

APPROVAL OF AGENDA

On motion by Mr. Lightsey, second by Mr. McCartney, the Board of Trustees voted unanimously to approve the agenda.

SECTION VII COLLEGE SPOTLIGHT – SHELTON STATE COMMUNITY COLLEGE

Dr. Jonathan Koh, President of Shelton State Community College, stated that over the last two years, a new college-wide initiative, Service in Action, has been implemented. This initiative is designed to bring the college's purpose and intent to life. The focus is on helping people achieve their goals and potential. The college has been laser-focused on making enrollment and registration easy, and on bringing people from the non-credit side to the credit side in line with the college's mission. Dr. Koh added that partnerships have made the strategic enrollment growth possible, in particular, the Adult Education program. The college has learned how to leverage and benefit from federal financial aid, such as Pell Grants. Partnership with the Juvenile Detention Center in Tuscaloosa County is also providing great success. At the Detention Center, Shelton State has its own dorm cell, the Leadership Dorm, in which the college works and provides training. Dr. Koh introduced Mr. Dalton Peters, whom the college met at the Juvenile Detention Center and mentored all the way through graduation and full-time employment with the college.

Mr. Peters briefly spoke on his success story with Shelton State. He stated that he came from a very poor background with little hope, but his mother had always told him how important it was to get a good education. After getting involved in drugs and alcohol, and getting into trouble, he eventually found himself at the Juvenile Detention Center. While there, he realized that he needed to make a change, and enrolled in Shelton State, which gave him structure, discipline, and the second chance he needed. He earned his GED and then a degree in Psychology. Mr. Peters added that the college not only gave him direction, but a community who cared. He now works as a full-time Educational Pathway Specialist at Shelton State and helps others who are in the same situation he was in. He added that the college doesn't just provide education, but transformation, and hope for the future.

On motion by Mr. Lightsey, second by Mr. Houston, the Board of Trustees authorized the President of Calhoun Community College to name the Advanced Technology Center on the Decatur campus as the Gene Haas Workforce Training Center and to add appropriate signage.

DRAKE STATE COMMUNITY & TECHNICAL COLLEGE INCREASE IN SPECIAL BUILDING FEE

On motion by Mr. Houston, second by Mr. Shell, the Board of Trustees authorized Drake State Community & Technical College to increase its Special Building Fee from \$15 to \$20 per credit hour. The increased fee will take effect Spring Semester 2026.

Fiscal Consideration: \$100,000 Estimated additional revenue annually

BISHOP STATE COMMUNITY COLLEGE
ASSOCIATE IN APPLIED SCIENCE IN AVIATION MANUFACTURING TECHNOLOGY

On motion by Mr. Shell, second by Mr. Rhone, the Board of Trustees approved Bishop State Community College's application for an Associate in Applied Science in Aviation Manufacturing, to be implemented Spring Semester 2026.

Fiscal Consideration: The College estimates that a total of \$329,798 is required to support the program and \$1,976,400 is projected to be available through tuition and extramural funds.

CALHOUN COMMUNITY COLLEGE ADDITION OF INSTRUCTIONAL SITE

On motion by Mr. McCartney, second by Mr. Shell, the Board of Trustees approved an additional instructional site for Calhoun Community College.

Fiscal Consideration: The operation of this site proposed herein is within the budget of the college.

CALHOUN COMMUNITY COLLEGE ASSOCIATE IN APPLIED SCIENCE IN THEATRE DESIGN AND TECHNOLOGY

On motion by Mr. Lightsey, second by Mr. Houston, the Board of Trustees approved Calhoun Community College's application for an Associate in Applied Science in Theatre Design and Technology, to be implemented Spring Semester 2026.

Fiscal Consideration: The College estimates that a total of \$36,000 is required to support the program and \$137,500 is projected to be available through tuition and extramural funds.

REID STATE COMMUNITY COLLEGE ASSOCIATE IN ARTS (TRANSFER DEGREES)

On motion by Mr. Shell, second by Mr. Rhone, the Board of Trustees approved Reid State Community College's application for an Associate in Arts (Transfer Degrees), to be implemented Spring Semester 2026.

Fiscal Consideration: The College estimates that a total of \$614,000 is required to support the Associate in Arts and \$877,345 is projected to be available through internal allocations, tuition, and extramural funds.

REID STATE COMMUNITY COLLEGE ASSOCIATE IN SCIENCE (TRANSFER DEGREES)

On motion by Mr. Houston, second by Mr. Shell, the Board of Trustees approved Reid State Community College's application for an Associate in Science (Transfer Degrees), to be implemented Spring Semester 2026.

Fiscal Consideration: The College estimates that a total of \$614,000 is required to support the Associate in Science and \$877,345 is projected to be available through internal allocations, tuition, and extramural funds.

ALABAMA COMMUNITY COLLEGE SYSTEM ALLOCATION OF FY2025-2026 INDUSTRY CERTIFICATION INITIATIVE FUNDS (SKILLS USA)

On motion by Mr. Shell, second by Mr. Lightsey, the Board of Trustees authorized the Chancellor to distribute through grants the sum of \$1,000,000 from the legislative appropriation for Industry Certification Initiative funds to support existing industry training. Individual grants awarded by the Chancellor shall be limited to a maximum of \$15,000 per training project, with an annual limit of \$60,000 for each company, for the purpose of providing training for existing businesses. The Chancellor and his staff are authorized and encouraged to use all appropriate means to expedite the award of grants to timely meet the needs of existing businesses

Fiscal Consideration: \$1,000,000 – FY2025-2026 Education Trust Fund Industry Certification Initiative Funds

ALABAMA COMMUNITY COLLEGE SYSTEM ALLOCATION OF FY2025-2026 INDUSTRY CERTIFICATION INITIATIVE FUNDS

On motion by Mr. Houston, second by Mr. Rhone, the Board of Trustees authorized the Chancellor to distribute \$250,000 in Industry Certification Initiative funds, from the current legislative appropriation, through grants to address immediate workforce development training needs. It is also recommended that the Chancellor be authorized to reallocate any unused funds from the previous fiscal year for the same purpose.

SECTION XI CHANCELLOR'S REPORT

Dr. Neil Scott, Vice Chancellor of Student Success, presented the latest enrollment numbers. Per Dr. Scott, the Fall 2025 Semester shows a 7.9% increase in enrollment over Fall 2024, with 95,185 students in for-credit courses. This is 6,925 more students than last year. Credit hours show a 7.4% increase over Fall 2024.

Chancellor Baker stated that consideration is currently being given to prison education and, over the next several months, a task force with membership from multiple agencies will be formed to discuss opportunities within the prison system. The ACCS will participate in this task force. Our mission is to provide training programs so incarcerated individuals will have a skill and a job to look forward to once they have served their time. Updates on this project will be forthcoming.
